I wanted to thank each and every member and exhibitor for allowing me the privilege and opportunity to go over your Irish Wolfhounds. I assure you this was a wonderful experience for me surrounded with quality hounds and their loving owners and breeders. I especially would like to thank Risha and David for their hospitality along with Courtney and Maria for shuttling me to and from the hotel, show sight and a very nice judges' dinner!

The match show venue was spacious, and the flooring was solid and cushioned for the hounds to strut their stuff with ease. Awards were beautiful and hopefully those that received this pottery will cherish it as much as I cherish mine as a judge's gift. Thank you GLIWA!

What better way to spend a Saturday than going over an Irish Wolfhound entry from puppies to veterans? To top it off the dogs were sound and in good temperament. My ring steward David had everything under control so I could totally focus on my assignment. As you will read in my critique, I strongly look at the front assembly of our hounds, since this in my opinion, is where we always need to strive to improve. This is not to say I am overlooking other points in the standard, but when you come across good return of upper arm with equal length from point of scapula to point of shoulder it needs to be rewarded. In our breed correct fronts are so vital for easy, active and efficient movement along with supporting the majority of the hound's weight. This is why one of my two points of emphasis was to talk about fronts along with coat. It is my hope that we all have a better understanding of the front assembly by talking about it, studying it and ultimately striving to breed it and keep it in our lines.

I hope everyone enjoyed the match show as much as I did. We are so fortunate to be stewards of this breed and to be blessed with so many wonderful, responsible people.

*Study Identifies Differences
In DCM-Associated Diets*



Recent study results provide details on the biochemical differences between diets associated with dilated cardiomyopathy in dogs and those with no known connection to the disease.

Researchers from the U.S. Department of Agriculture and Tufts University profiled nine canine diets associated with canine DCM. Each contained at least three pulses ingredients such as peas and lentils, potatoes, or sweet potatoes among their ingredients, and each was identified by the Food and Drug Administration as among the diet brands most often associated with DCM cases reported to the agency, according to a scientific article published

Aug. 5 by Scientific Reports. The researchers also profiled nine diets with no known association with DCM.

DCM is one of the most common heart diseases of pet dogs, causing chambers of the heart to dilate and pump blood less effectively. Dogs can develop congestive heart failure or unexpected death.

The disease historically affected mostly large-breed dogs and Cocker Spaniels. In July 2018, FDA officials warned they had received reports of DCM in dogs of other breeds.

In 2020, agency officials indicated they had received 1,100 adverse event reports linked with DCM since January 2014, and they planned to collaborate with researchers on studies into nonhereditary DCM, including its possible link to diet.

FDA representatives have indicated in presentations that more than nine in 10 dogs with identified DCM in reports had eaten diets high in peas, lentils, or both.

For the recent Scientific Reports article, the researchers identified, measured, and compared concentrations of 830 biochemical compounds within the foods, 665 of them known and 165 unknown.

They found that diets associated with DCM had lower volumes of B vitamins, which are co-factors in reactions related to cardiac metabolism such as carnitine and taurine synthesis. DCM-associated diets also had higher concentrations of amino acids, amino acid derivatives, and plant-derived compounds, some of which could contribute to deficiencies in molecules essential to heart function by, for example, influencing carnitine metabolism, the article states. The researchers also found no significant difference in concentrations of taurine. Dietary taurine deficiency is a cause of DCM in cats.

The article authors identified a few ingredients in particular that appear to contribute to the biochemical differences among the diets: peas, lentils, rice, and chicken or turkey meat. Peas and, to a lesser degree, lentils appear to be the main sources of elevated concentrations of certain biochemical compounds in the DCM-associated diets, the article states.

"While we cannot establish with certainty if any of these compounds and ingredients are causal for disease, the findings support peas as a leading possible ingredient associated with diet-associated DCM in dogs," the article states.

Panosteitis in Dogs

What is panosteitis?

Panosteitis is a painful inflammation of the outer surface or **shaft** of one or more long bones of the legs. It is sometimes called growing pains. Panosteitis may occur in more than one bone at a time or may move around, causing a shifting lameness that goes from one bone or leg to another. The lameness tends to occur very suddenly and usually occurs spontaneously and without a history of trauma or excessive exercise.



Are all dogs affected with this condition?

Panosteitis is a condition that affects young, rapidly growing dogs. Although it can occur in any breed of dog, larger breeds, such as German Shepherds (most common), Great Danes, Golden Retrievers, Labrador Retrievers, Rottweilers, Doberman Pinschers, and Basset Hounds, are more prone to this problem.

Affected dogs are usually between 5 and 14 months of age, but the first symptoms may occur as early as 2 months of age or as late as 18 months of age. Males seem to be affected more often than females, although either sex can develop panosteitis. Affected dogs often have recurrent episodes of panosteitis until they reach 2 years of age, at which time it will spontaneously resolve.

What is the cause?

Panosteitis is a painful condition, and the pain is likely caused by increased pressure within the bone, and/or by stimulation of pain receptors in the **periosteum** (outer, soft tissue lining of the bone). The underlying cause of panosteitis is unknown, but genetics, stress, infection, metabolism, or an autoimmune component may be factors. Since German Shepherds seem to be

particularly predisposed to panosteitis, there may be a genetic component to the disease, at least in this breed. Inappropriate nutrition may also predispose some dogs to this condition.

What are the clinical signs?

The typical symptom is a sudden, unexplained, painful lameness of one or more legs. The lameness may be mild or severe. The most common bone that is affected is the **humerus** (upper arm), but panosteitis may also be found in the **radius** and **ulna** (both bones in the foreleg), the **femur** (thigh) and/or the **tibia** (lower rear leg). The affected bone will be painful to the touch. Other symptoms such as fever, anorexia, lethargy, or weight loss may be noticed.

Panosteitis tends to have a cyclic nature, with periods of worsening symptoms followed by periods of improvement. The pain often shifts from leg to leg. Each episode of lameness may last for a few days to a few weeks, and the period between episodes is often about a month, but may vary.

How is it diagnosed?

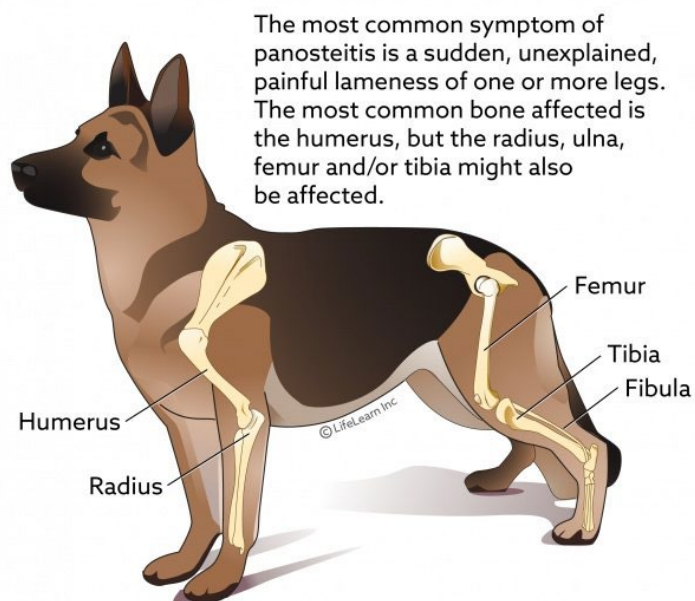
When your veterinarian examines your dog, panosteitis will be suspected if the patient shows pain when pressure is applied to the affected bone(s). The diagnosis is confirmed by radiographs (X-rays), which usually show a characteristic increase in the density of the affected bones. The degree of change may not correlate to the severity of the lameness. In some cases, radiographic evidence may not be present for up to ten days after lameness begins; in these cases, repeat X-rays taken 2 weeks later will confirm the diagnosis. After the condition has resolved, the bone density normalizes and the bone looks normal on radiographs.

What is the treatment?

Although this disease is self-limiting, and will spontaneously resolve, during episodes of lameness the condition is very painful. At these times, treatment is supportive, using analgesics (pain medications) and/or anti-inflammatory drugs (e.g., meloxicam, brand name Metacam®) as needed.

During episodes of lameness, exercise should be restricted. Between episodes, light to moderate exercise should be encouraged, but hard or vigorous exercise is discouraged, as are very long walks.

Some dogs with panosteitis have a poor appetite; in these cases, it is important to ensure that they are given a properly balanced and palatable diet. In some cases, supplements such as nutraceuticals, omega-3 fatty acids, or antioxidants may be helpful.

What is the prognosis?

Panosteitis is a self-limiting disease, meaning that it will eventually go away. The disease should be completely resolved by the time the dog reaches 18-24 months of age. Each episode of lameness should last no longer than 3 weeks; if your pet's lameness persists without relief for longer than 4-5 weeks, it is likely that the dog is affected with another bone disorder (see handout on "Bone Diseases of Growing Dogs" for further information).

If panosteitis is a self-limiting disease, why is it necessary to perform diagnostic procedures such as radiographs?

Although panosteitis is not a serious disease, and is a common cause of lameness, other, more serious bone diseases can cause lameness in young dogs. In order to be sure that a sudden onset of lameness is not caused by one of these more serious bone diseases, radiographs must be taken. If the radiographs show the typical lesions of panosteitis, then you can rest assured that your dog will eventually outgrow the problem.

Are there any preventive measures I can take to prevent panosteitis in my large breed dog?

Although there are potential links between diets containing excessive levels of dietary protein and/or calcium, it is contraindicated to feed large breed puppies with an adult dog food that contains lower levels of protein and calcium. The reason for this is that adult dog food also has lower calories or energy levels than puppy food. Rapidly growing puppies require higher levels of dietary energy to meet the needs of growth, and will need to eat more of a low-energy food to meet these requirements. Eating more of a low energy diet will result in a higher overall intake of protein and calcium.

A better option is to feed an affected dog a high quality diet that has been specifically formulated for use in large breed puppies or adolescents, and to restrict the quantity fed to keep the dog at a lean, healthy body weight. Do not allow your puppy to become overweight. Consult your veterinarian for further advice on the most appropriate nutrition for your dog.

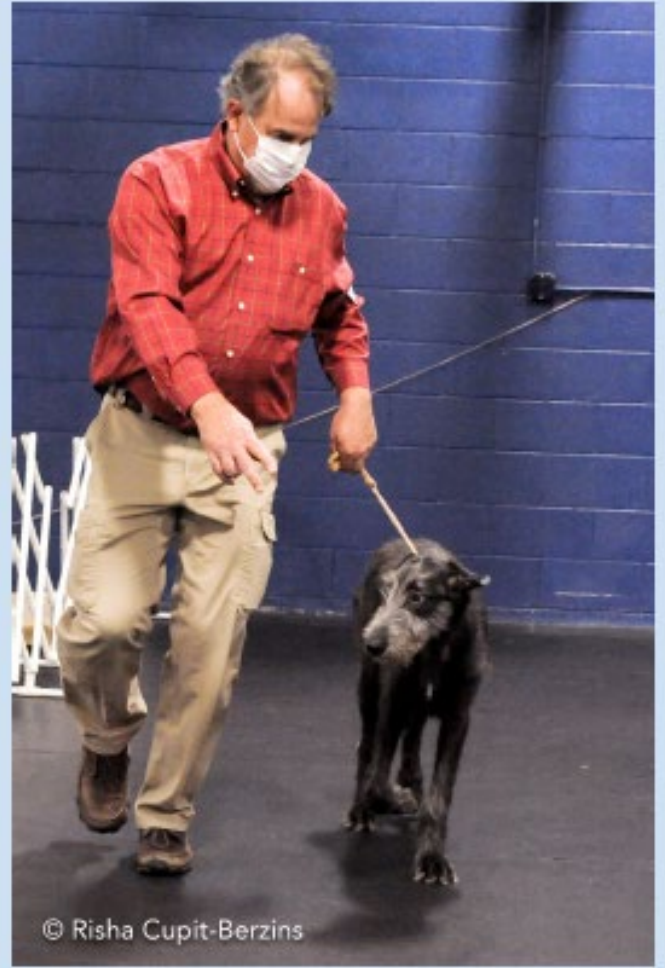

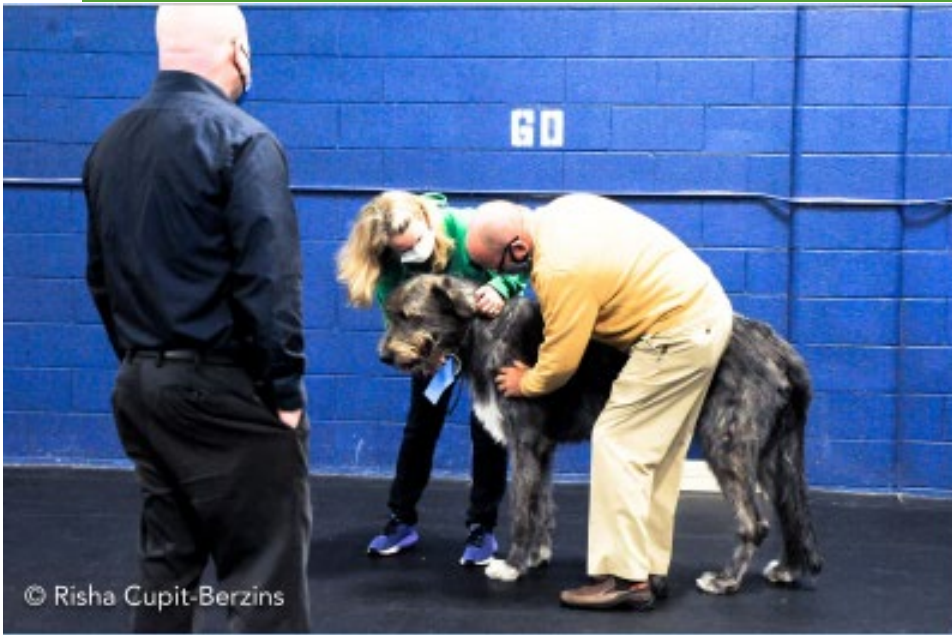
